RESOLUTION NO. 2022-244

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH THE CLAYTON COUNTY LIBRARY SYSTEM, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH CLAYTON COUNTY PUBLIC SCHOOLS FOR AN ADULT EDUCATION PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County, through the Clayton County Library System (the “Library”), wishes to enter into a Memorandum of Understanding (“MOU”) with Clayton County Public Schools (“CCPS”) for an Adult Education Program (“Program”); and

WHEREAS, the Program will provide high school equivalency preparation and testing, adult literacy instruction, English as a second language instruction, civics education, and family literacy programs; and

WHEREAS, the Program will provide preparatory courses to assist residents of Georgia to acquire basic skills in reading, writing, and math computation, and prepare non-English-speaking residents with important English proficiency tests with online classes; and

WHEREAS, working with CCPS to carry out the Program will ensure that students receive services from qualified instructors, use appropriate curriculum and instructional materials, and provide academic counseling, career exploration services, and postsecondary transition support; and

WHEREAS, working with CCPS will allow Program participants to be ready for employment with improvement in literacy, and non-English speaking participants will be able to obtain and retain better employment; and

WHEREAS, there is no cost to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the

County will best be served by entering into the Memorandum of Understanding with Clayton County Public Schools for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, through the Clayton County Library System, to enter into a Memorandum of Understanding with Clayton County Public Schools for an Adult Education Program. The Memorandum of Understanding shall be in substantially the form attached hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and/or Chairman of the Board of Commissioners may approve. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Memorandum of Understanding, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
