RESOLUTION NO. 2022-257

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT EMERGENCY RENTAL ASSISTANCE GRANT 2 FUNDS FROM THE UNITED STATES DEPARTMENT OF TREASURY UNDER THE AMERICAN RECOVERY PLAN ACT OF 2021 FOR AN EMERGENCY RENTAL ASSISTANCE PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Treasury (“Department of the Treasury”) has previously provided Clayton County (“the County”) allocations under the United States CARES Act for an Emergency Rental Assistance Program and to assist eligible households with rental assistance on an emergency basis, as well as for the administration of the same; and

WHEREAS, the Department of the Treasury with funds authorized by the American Rescue Plan Act of 2021 has reallocated \$433,938.61 in additional funds to the County for Emergency Rental Assistance to provide households with financial assistance to avoid evictions (“Grant”); and

WHEREAS, the County is authorized to use no more than ten (10) percent (%) for Administrative costs; and

WHEREAS, acceptance of these funds will allow the County to continue to assist families with rental assistance and provide case management services for stable housing; and

WHEREAS, this reallocation of Emergency Rental Assistance Grant 2 program funds will have a funding period of January 2021 – December 31, 2025; and

WHEREAS, the County wishes to accept reallocated Grant funds from the United States Department of Treasury American Recovery Plan Act for an Emergency Rental Assistance Program; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by accepting the grant funds for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to accept the reallocated Emergency Rental Assistance Grant 2 funds from the Department of Treasury in the amount of \$433,938.61. These funds will fund Clayton County's existing Emergency Rental Assistance Program. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the budget to reflect appropriations and expenditures all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
