RESOLUTION NO. 2022 - 280

A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ACCEPT A VEHICLE SEIZED FOR FORFEITURE BY THE CLAYTON COUNTY SHERIFF'S OFFICE; TO AUTHORIZE THE VEHICLE FOR COUNTY USAGE AND ASSIGN THE VEHICLE TO THE CLAYTON COUNTY SHERIFF'S OFFICE; TO AUTHORIZE THE CHAIRMAN, CENTRAL SERVICES, FLEET MAINTENANCE, AND THE CHIEF FINANCIAL OFFICER TO TAKE ALL ACTIONS NECESSARY TO ACHIEVE THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Office seized a maroon, 2019 Dodge Ram 1500, VIN 1C6SRFJT3KN719377; and

WHEREAS, the Defendant has forfeited the ownership of said vehicle to the County in a final order in seizure case number 2022CV02337-10, as long as the Clayton County Sheriff's Office uses said vehicle for law enforcement purposes; and

WHEREAS, the Clayton County Fleet Maintenance Department has recommended the unit for service as a County vehicle; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by placing said vehicle in the Clayton County Department's Fleet for use by the Sheriff's Office in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to 2019 Dodge Ram 1500, VIN 1C6SRFJT3KN719377 seized and to assign

said vehicle to the Clayton County Sheriff's Office for the purpose of enhancing law enforcement.

Section 2. The Board of Commissioners authorizes the Chairman, Central Services, Fleet Maintenance, and the Chief Financial Officer to perform all acts necessary to effect this resolution.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
