RESOLUTION NO. 2019 – 34

A RESOLUTION TO AUTHORIZE THE CHAIRMAN TO EXECUTE FILM LOCATION AGREEMENTS; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners (“the Board”) recognizes that the State of Georgia and Clayton County (“the County”) in particular has been a hub for film and television production activity for several years; and

WHEREAS, the Board notes that in 2018, the County attracted a mix of feature film and television production projects including projects from Pinewood Studios, DC Comics’ Doom Patrol, and Netflix; and

WHEREAS, film and television productions recorded approximately 100 days of filming in Clayton County in 2018 and the County continues to receive a flurry of location scout calls for film and television projects in 2019; and

WHEREAS, the Board desires to foster a film-friendly community that welcomes Hollywood and continues to grow the County’s filming portfolio, strengthen relationships with production personnel, develop new tourism products and increase the film client base; and

WHEREAS, the Board recognizes that there may be occasions where time is of the essence to film at a specific County location and the proposed time to film falls between a scheduled Board meeting; and

WHEREAS, in fostering a film-friendly community, the Board desires to accommodate the schedules of film and television producers when time is of the essence; and

WHEREAS, the Board hereby desires to set forth a process for execution of film location agreements in such expedited instances.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. In those instances where time is of the essence and the County's accommodation of a film or television producer's location request may be lost due to the timing of the request in relation to a meeting of the Board of Commissioners, the Board of Commissioners hereby grants to the Chairman authority to execute a film location agreement for television and/or movie filming on County property in an amount not to exceed \$50,000.00 for use of County property after review and approval of the proposed agreement and any related documents by the County's legal counsel. After execution of the proposed agreement and related documents by the Chairman, a signed copy of the executed agreement and any related documents shall be forwarded to the department of Central Services and the agreement shall be placed on the next agenda of the Board of Commissioners for approval on the minutes.




