RESOLUTION NO. 2019-93

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF RIVERDALE PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE CITY OF RIVERDALE WILL BE ALLOWED USE OF COUNTY PROPERTY FOR RECREATIONAL ACTIVITIES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET AS NEEDED TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (“the County”) and the City of Riverdale (“the City”)(collectively referred to as “the Parties”) desire to maintain a mutually beneficial, efficient and cooperative relationship that will promote the interests of the citizens of both jurisdictions; and

WHEREAS, the Parties to this Agreement are both governmental units; and

WHEREAS, the City is interested in using certain property owned by the County located at 8970 Thomas Road, Jonesboro, GA 30238 (“the Property”) for recreational programs; and

WHEREAS, the City desires to contract with the County to set forth the rights and responsibilities of the Parties pursuant to the applicable laws of the State of Georgia; and

WHEREAS, the City and the County are authorized by Art. IX, Sec. III, Par. I of the Constitution of the State of Georgia to enter into such an agreement for the use of the Property; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by entering into an Intergovernmental Agreement with the City for the reasons contemplated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into an intergovernmental agreement in substantially the form as that attached hereto as "Attachment A" with the City of Riverdale (the "City") providing for the terms and conditions under which the City will use property owned by the County located at 8970 Thomas Road, Jonesboro, GA 30238 ("the Property") for recreational activities. The Board of Commissioners hereby authorizes the Chairman to execute the agreement and to otherwise perform all acts necessary to accomplish the intent of the Resolution. The Board further authorizes the Chief Financial Officer to amend the Budget as needed to reflect an appropriate revenue source and expense all as may be required under the terms of the agreement.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






