RESOLUTION NO. 2019 - 99

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY SENIOR SERVICES DEPARTMENT, TO EXECUTE A LICENSE AGREEMENT WITH BLACK VETERANS HELPING VETERANS CORPORATION, TO HOST A FUNDRAISER AT THE J. CHARLEY GRISWELL SENIOR CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Senior Services Department received a Special Facility Use Request (the "Request") from Black Veterans Helping Veterans Corporation (the "Promoter") for use of the J. Charley Griswell Senior Center (the "Senior Center") for the purpose of hosting a fundraiser; and

WHEREAS, the Senior Center will be utilized between the hours of 4:00 p.m. to 8:00 p.m. on Saturday, September 7, 2019; and

WHEREAS, the Director of the Senior Services Department recommends that Promoter pay the half price rate for the Special Event Fee (\$370.00) during the event, for a total payment of \$370.00 to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Senior Center and executing a license agreement for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Senior Services Department, to execute a license agreement with Black Veterans Helping Veterans Corporation to host a fundraiser at the J. Charley Griswell Senior Center on September 7, 2019, and also authorizes the Chairman to execute the documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 2. Black Veterans Helping Veterans Corporation will pay the half price rate for the Special Event Fee (\$370.00) during the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by the Clayton County Risk Management Department.




