RESOLUTION NO. 2019-133

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY WATER AUTHORITY TO OBTAIN A TEMPORARY CONSTRUCTION EASEMENT OVER CERTAIN PROPERTIES IN CLAYTON COUNTY TO LAY AND CONSTRUCT UTILITY PIPES, STRUCTURES AND/OR FACILITIES; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

**WHEREAS**, the Clayton County Board of County Commissioners (hereinafter referred to as the "Board") has determined that in order for it to provide for the increasing sanitary sewer needs of Clayton County, the Clayton County Water Authority (hereinafter referred to as the "Authority") must initiate construction projects to lay and construct utility pipes, structures and facilities on, over, across, or under certain property located in Clayton County identified by tax map parcel number 13173D C021 located at 0 Valley Hill Rd., Riverdale, Clayton County, Georgia, said project and utility lines being more particularly shown and described in Exhibit "A", attached hereto and made a part hereof (hereinafter "the Location"), which is necessary for the Authority to continue to provide quality utility services to the citizens of Clayton County; and

**WHEREAS**, the Authority has chosen the Location for construction of utility pipes, structures and/or facilities so that said services will benefit residents of Clayton County with minimal disruption and inconvenience to property owners affected thereby; and

**WHEREAS**, there is a public necessity that the utility facilities be laid and constructed for the sanitary sewer needs of property owners in Clayton County; and

**WHEREAS**, the Authority has diligently pursued and will continue to pursue obtaining the necessary temporary construction easement on, over, across, or under the Location; and

**WHEREAS**, the County and Authority consent to the Authority obtaining a temporary construction easement at the Location.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY AND IT IS HEREBY RESOLVED

**BE IT RESOLVED** that the Board does hereby declare that there is a public necessity that the Authority acquire a temporary construction easement of varying widths over, across, under and through the property identified by tax map parcel number 13180D C001B located at 0 Valley Hill Rd., Riverdale, Clayton County, Georgia, as shown on Exhibit "A" attached hereto and incorporated herein by reference during the period of construction for the purpose of ingress and egress for laying and constructing utility pipes, structures and/or facilities and all appurtenances thereto.

**BE IT FURTHER RESOLVED** that the Board of Commissioners authorizes the Chairman to execute any required documents and otherwise perform all acts necessary to accomplish the intent of this Resolution.






