A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA TO SUPPORT A SEX TRAFFICKING AWARENESS WORKSHOP HOSTED BY COMMISSIONER SONNA GREGORY TO BE HELD ON DECEMBER 7, 2019 AT THE CARL RHODENIZER RECREATION CENTER; TO AUTHORIZE THE COUNTY AND ITS DEPARTMENTS TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, human trafficking and sex trafficking are problems that have been addressed by the Georgia legislature with increased penalties and by Georgia law enforcement with increased personnel dedicated to eradicate this issue; and

WHEREAS, Georgia is a leader in the nation in combating this crime and studies show that there is a rise in awareness in human trafficking in Georgia; and

WHEREAS, Ladies of Favor, Inc. and the office of Commissioner Sonna Gregory desire to continue to raise awareness of this issue by collaborating for a discussion regarding the reality of child sex trafficking; and

WHEREAS, Commissioner Sonna Gregory wishes to utilize the Carl Rhodenizer Recreation Center on December 7, 2019 from 12:00pm – 2:00pm to host a sex trafficking awareness workshop with Dr. Gabrielle Starr (“the Event”); and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by supporting the Event.

CLAYTON COUNTY AND IT IS HEREBY RESOLVED


Section 1. The Clayton County Board of Commissioners hereby supports a sex trafficking awareness workshop hosted by Commissioner Sonna Gregory in partnership with Ladies of Favor, Inc. and Dr. Gabrielle Starr to be held on December 7, 2019 at the Carl Rhodenizer Recreation Center between 12pm – 2:00pm (“the Event”).

Section 2. The Board of Commissioners hereby authorizes the County and its departments to work in conjunction with the intent of this resolution. The Board of Commissioners further authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense.






