RESOLUTION NO. 2020 – 41

A resolution authorizing Clayton County to enter into an agreement with the Senior Community Service Employment Program providing for the terms and conditions under which Clayton County will provide training services to eligible participants; to authorize the Chairman to execute the agreement and otherwise to perform all other acts necessary to accomplish the intent of this resolution; to authorize the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense; to provide an effective date of this resolution; and for other purposes.

WHEREAS, the National Council on Aging has a Senior Community Service Program (“SCSEP”) which provide useful part-time community service assignments for persons with low incomes who are 55 years old or older, while promoting transition to unsubsidized employment; and

WHEREAS, SCSEP matches eligible older adults with part-time training assignments for non-profit organizations; and

WHEREAS, Legacy Links, as the administrator of SCSEP, has reached out to the County’s library system for possible sites for assigning some of their part time workers; and

WHEREAS the County has a need for stability in part-time jobs in the Library system and can use these workers to help complete the digital library card conversion project, to help with outreach activities and to help maintain the County’s library collection on the shelves; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by entering into an Agreement with the National Council on Aging to provide work experience for eligible participants.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into an Agreement with the National Council on Aging through its Senior Community Service Employment Program providing for the terms and conditions under which the County will provide training services to eligible participants. The Agreement will be executed in substantially the same form as Exhibit A. The Board hereby authorizes the Chairman or his designee to execute the Agreement and to perform all other acts necessary to accomplish the intent of this Resolution. The Board further authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




