RESOLUTION NO. 2020 – 43

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND ACCEPT GRANT FUNDS FROM UNITED WAY OF GREATER ATLANTA (BRIGHTER FUTURES); TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County has received a grant in the amount of \$5,000.00 allocated for the 2020 Census for outreach initiatives to minorities and African-American males in the Clayton County community; and

WHEREAS these funds will help the County engage all citizens via social media, in-person, County functions, and 3-4 separate Census Day events which will take place during the 2020 Census response timeframe between March 14th and April 1, 2020 and beyond, as needed; and

WHEREAS, the County desires to apply and accept grant funding in the amount of \$5,000.00 allocated for the 2020 Census to bridge the gap between information and action as it pertains to completing the 2020 Census survey.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to apply for and accept a grant through United Way of Greater Atlanta (Brighter Futures) for

\$5,000.00 allocated for the 2020 Census to expand outreach to minorities and African-American male members of the Clayton County community between now and June 30, 2020. The Board authorizes the Chairman to execute any Agreement and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




