RESOLUTION NO. 2020 - 46

A RESOLUTION TO FORMALLY ACCEPT THE REMOVAL OF STATE ROUTE 920 ALSO KNOWN AS MCDONOUGH ROAD FROM THE STATE HIGHWAY SYSTEM OF ROADS; TO TERMINATE AN AGREEMENT FOR MAINTENANCE OF HIGHWAYS BETWEEN GEORGIA DEPARTMENT OF TRANSPORTATION AND CLAYTON COUNTY NUMBERED 3087M; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in July 1994, the Board of Commissioners of Clayton County ("the County") entered into an agreement numbered 3087M with the Georgia Department of Transportation ("GDOT") to temporarily designate McDonough Road in Clayton County to be added to the State Highway System ("the System") as State Route 920 for right of way construction and other projects; and

WHEREAS, GDOT has constructed and made improvements to State Routes 20 and 81 which require modification of the System to include intersection improvements, additions to the System and removal of previously designated portions of State Routes as part of the System; and

WHEREAS the Commissioner of GDOT has notified the County of the decision to permanently remove State Route 920 as a temporarily designated State Route from the System; and

WHEREAS, the removal of this designation is an administrative data change only and will not result in any title, maintenance, utility accommodation, ownership or physical changes to the roadway; and

WHEREAS, the County intends to formally accept the removal of State Route 920 also known as McDonough Road from the System; and

WHEREAS, the County also desires to terminate the Agreement between the County and GDOT numbered 3087M as it relates to the temporary designation of State Route 920 as a part of the System.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby formally accepts the removal of McDonough Road designated as State Route 920 from its temporary designation as State Route 920 within the State of Georgia Highway System. The County further terminates the July 1994 Agreement numbered 3087M between the County and the Georgia Department of Transportation ("GDOT") as it relates to the temporary designation of State Route 920 as part of the State Highway System. To the extent required by GDOT regulations and requirements, this Resolution also acts as formal acceptance of McDonough Road into the County's official system of roads.

Section 2. The Board authorizes the Chairman to execute the February 4, 2020 letter from GDOT approving the amendments to the State Highway System in substantially the form as attached hereto as Exhibit A and to otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be effective immediately upon approval by the Board of Commissioners.




