RESOLUTION NO. 2020 - 70

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ADOPT AND SUBMIT THE CLAYTON COUNTY PY2020 ANNUAL ACTION PLAN TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND TO AMEND THE CLAYTON COUNTY PY2017, PY2018, AND PY2019 ANNUAL ACTION PLANS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS REQUIRED AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has prepared its proposed PY2020 Annual Action Plan (the "Plan") and, upon adoption, will submit the Plan along with applications for the Community Development Block Grant (CDBG) Program, Home Investment Partnership Act (HOME) and Emergency Solutions Grant (ESG) Programs, and the Neighborhood Stabilization Program (NSP) to the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, Clayton County proposes amendments to its PY2017, PY2018 and PY2019 Annual Action Plans detailing the recapture and reuse of funding for the CDBG program; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by adopting the PY2020 Annual Action Plan as

proposed and amending the PY2017, PY2018 and PY2019 Annual Action Plans for the stated purposes.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA AND IT IS HERBEY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the adoption and submission of the PY2020 Annual Action Plan, and authorizes the approval of CDBG Amendments to the Clayton County PY2017, PY2018 and PY2019 Annual Action Plans as proposed. The Board of Commissioners hereby authorizes the Chairman to execute any documents required for submission and implementation of these Plans and Amendments, and to perform all other acts necessary to accomplish the intent of this Resolution. Furthermore, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect appropriate revenue sources and expenses, all as may be required under the terms of the Plans and the Amendments.

Section 2. This Resolution shall be effective on the date of its approval by the Clayton County Board of Commissioners.




