RESOLUTION NO. 2020-84

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT SUPPLEMENTAL GRANT FUNDS FROM ATLANTA REGIONAL COMMISSION FOR THE AGING PROGRAM TO PROVIDE IN-HOME SERVICES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY AGREEMENT(S) AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in July 2019, the Clayton County Board of Commissioners (“the County”) accepted grant funds awarded by the Atlanta Regional Commission (“ARC”) for the Aging Program for Fiscal Year 2020; and

WHEREAS, ARC has made available additional grant funds in the amount of \$28,000.90 to provide in-home services for seniors; and

WHEREAS, the County, through the Senior Services Department, desires to accept this additional grant funding from the ARC for costs relating to providing in-home services for seniors to serve more clients and improve the health and welfare of its citizens.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to accept grant funds from the Atlanta Regional Commission for the Aging Program in an amount up to \$28,000.90 for costs associated with providing in-home services for seniors. The Board authorizes the Chairman to execute any Agreement(s) and to otherwise perform all acts


necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.




