RESOLUTION NO. 2020-111

A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ACCEPT GRANT FUNDS FROM THE STATE OF GEORGIA COUNCIL OF ACCOUNTABILITY COURT JUDGES FUNDING COMMITTEE AND THE CRIMINAL JUSTICE COORDINATING COUNCIL FOR THE CLAYTON COUNTY DRIVING UNDER THE INFLUENCE ACCOUNTABILITY COURT PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL NECESSARY DOCUMENTS AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (the "County"), on behalf of the Clayton County Driving Under the Influence Accountability Court Program (the "Court") has been awarded grant funds in the amount of \$29,183.00 from the State of Georgia Council of Accountability Court Judges Funding Committee and the Criminal Justice Coordinating Council, and the County now wishes to accept those funds, with a local match of \$3,243.00 required from the County; and

WHEREAS, the County's required local match may be made through in-kind contributions with no financial impact on the County; and

WHEREAS, the grant period is July 1, 2020 until June 30, 2021; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by accepting the grant funds, as described above.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept grant funds in the amount of \$29,183.00 on behalf of the Clayton County Driving Under the Influence Accountability Court Program for the purpose of supporting program needs with a \$3,243.00 local match required from the County which may be made through in-kind contributions with no financial impact on the County.



Section 3. The Board of Commissioners hereby authorizes the Chief Financial Officer to amend the budget to reflect an appropriate revenue source and expense as necessary.

Section 4. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


