RESOLUTION NO. 2020 - 131

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE FEDERAL BUREAU OF INVESTIGATIONS TO PARTICIPATE IN THE ATLANTA MAJOR OFFENDERS VIOLENT CRIME TASK FORCE; TO AUTHORIZE THE CHAIRMAN OR THE CHIEF OF POLICE AS HIS DESIGNEE TO EXECUTE THE MOU; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; ALL AS MAY BE REQUIRED IN THE TERMS OF THE MOU; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Federal Bureau of Investigation ("FBI") has created the Atlanta Major Offenders Violent Crime Task Force ("Task Force") with participation from various area law enforcement agencies; and

WHEREAS, the Clayton County Police Department has been invited to participate in this valuable program; and

WHEREAS, the Clayton County Police Department currently participates in the FBI Safe Streets Task Force. The Safe Streets Task Force will merge into the new FBI Atlanta Major Offenders Violent Crime Task Force; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by participation in this TaskForce.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the Chairman of the Board of Commissioners, or the Chief of Police as the Chairman's designee to execute

a Memorandum of Understanding (MOU) with the Federal Bureau of Investigation (FBI) to participate in the Atlanta Major Offenders Violent Crime Task Force. The FBI may provide a vehicle for the Clayton County Police Officer assigned to the Task Force. Additionally, the Clayton County Police Department will use existing personnel to staff this Task Force. No additional police personnel will be necessary. The FBI will reimburse the County for overtime payments subject to the availability of funds. The Board of Commissioners also authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the MOU.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




