RESOLUTION NO. 2020-143

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A DONATION FROM CAN'D AID'S CRUSH IT CRUSADE ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT FOR THE PURPOSE OF CREATING A RECYCLING PROGRAM IN THE RECREATION FACILITIES; TO AUTHORIZE THE CHAIRMAN TO ACCEPT THE GRANT ON BEHALF OF CLAYTON COUNTY AND TO EXECUTE ANY NECESSARY DOCUMENTS, AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET TO REFLECT APPROPRIATIONS AND EXPENDITURES ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE GRANT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Can'd Aid's Crush It Crusade wishes to grant \$8,021.99 to the Clayton County Parks and Recreation Department, to create a recycling program in the Parks and Recreation Department, Recreation Facilities; and

WHEREAS, the creation of the recycling program will empower individuals, events, and communities to create sustainable recycling programs and provide training and assistance with upfront cost; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by the acceptance of the grant for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED



The Board of Commissioners hereby authorizes Clayton County to accept a \$8,021.99 donation from Can'd Aid's Crush It Crusade to assist the Clayton County Parks and Recreation Department, Recreation Facilities, for the purpose of creating a recycling program within the Department. The Board of Commissioners hereby authorizes the Chairman to execute any necessary documents, and otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


