ORDINANCE NO. 2020-148

AN ORDINANCE TO AMEND THE CODE OF CLAYTON COUNTY, GEORGIA, AS AMENDED, SPECIFICALLY, CODE OF CLAYTON COUNTY, GEORGIA, PART I, CHAPTER II "ADMINISTRATION," ARTICLE III "BOARDS, COMMISSIONS AND AUTHORITIES," DIVISION 1 "GENERALLY," SECTION 2-56 TO SET FORTH PROCESS FOR BOARD AND AUTHORITY APPOINTMENTS; TO REPEAL CONFLICTING LAWS, ORDINANCES, AND RESOLUTIONS; TO PROVIDE SEVERABILITY; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE CLAYTON COUNTY BOARD OF COMMISSIONERS AND IT IS HEREBY ORDAINED

Section 1. The Code of Clayton County, Georgia, as amended, is hereby further amended by amending Part I, Chapter II "Administration," Article III "Boards, Commissions, and Authorities," Division 1, "Generally," Section 2-56, subsection (1) to read as follows:

(1) Unless otherwise provided by law, every member of a board or authority shall have appointments of members by a nomination process and vote of the participating members of the board of commissioners. Each district commissioner and the chairman shall have exclusive authority to nominate one member of any board or authority with 5 or more members. Every individual nominated to a board or authority pursuant to this subsection must receive at least three affirmative votes of the board of commissioners to be appointed to the board or authority.

Section 2. All laws, ordinances and resolutions, or parts thereof, which conflict with the provisions of this Ordinance are hereby repealed.


Section 3. If this Ordinance in whole or in part is determined to be unconstitutional by any court of competent jurisdiction, such unconstitutionality shall not affect the remainder of this enactment, and such remainder shall remain in full force and effect.


Section 4. This Ordinance shall become effective immediately upon its approval by the Board of Commissioners.
