RESOLUTION NO. 2020-172

A RESOLUTION AUTHORIZING CLAYTON COUNTY THROUGH ITS OFFICE OF EMERGENCY MANAGEMENT TO ENTER INTO AN AGREEMENT WITH CLAYTON STATE UNIVERSITY TO ALLOW WORK FOR ELIGIBLE WORK-STUDY STUDENTS; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

**WHEREAS**, Clayton County Office of Emergency Management wishes to continue a work study agreement with Clayton State University (“CSU”); and.

**WHEREAS**, CSU’s financial aid department requested various eligible grants that are allotted to students who meet certain academic requirements; and

**WHEREAS**, the work-study program, and the related salaries, are paid through the federal government and in no way burden the County financially; and

**WHEREAS**, the Institution of CSU will make available to the Clayton County Fire & Emergency Services (CCFES) department students for the performance of specific work assignments associated with emergency preparedness; and

**WHEREAS**, CSU shall be deemed the employer of each student assigned to CCFES, but CCFES will be responsible for the direct supervision of the student; and

**WHEREAS**, CSU agrees to pay 100% of wages earned by students working up to 25 hours per week and CSU students working under the Federal Work-Study Program are eligible for

workers' compensation benefits, provided that they adhere to CSU published guidelines regarding such benefits; and

**WHEREAS**, the County will not incur a financial impact; and

**WHEREAS**, the Board deems it in the best interest of the County and the County will best be served by entering into this agreement for the stated purposes.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED




Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




