RESOLUTION NO. 2020-194

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR, AND IF AWARDED, ACCEPT GRANT FUNDS TO RECOUP EXPENSES RELATED TO EMERGENCY MANAGEMENT ACTIVITIES INCURRED DURING THE ON-GOING RESPONSE TO THE COVID-19 PANDEMIC; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through its Office of Emergency Management Department, wishes to apply for, and if awarded, accept grant funds to recoup expenses related to Emergency management activities incurred during the on-going response to the COVID-19 Pandemic; and

WHEREAS, applying for these funds will allow the County to recoup current expenditures and prepare itself for the upcoming winter season, which will likely produce a second round of COVID-19 infections, potentially coupled with influenza; and

WHEREAS, because of the Presidential Declaration DR4501, FEMA, through GEMA and State Declaration GA-DR4501, the Federal Government has opened the Public Assistance Grant Program for Emergency Protective Measures taken by a local municipality in its response to the COVID-19 Pandemic; and

WHEREAS, under the current calculation of 75% Federal with a 25% cost share, the County would stand to recoup an estimated \$416,571.55 of the \$555,428.74; and

WHEREAS, this could provide substantial and much needed aid to the County as the County continues to manage the current state of affairs and ensures the community has the resilience necessary to engage the emerging threat; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by accepting the grant funds for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to apply for, and if awarded, accept grant funds to recoup expenses related to Emergency Management activities incurred during the on-going response to the COVID-19 Pandemic. The Board of Commissioners hereby authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the budget to reflect appropriations and expenditures.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


