FACT SHEET

- Accountability Courts identify offenders with substance abuse issues and place them in intensive court-supervised programs. The Courts provide substance abuse treatment, community supervision, drug and alcohol testing, and frequent judicial monitoring.
- The mission of Accountability Courts is to reduce relapses of criminal behavior, enhance public safety, and promote healthier lifestyles.
- Accountability Courts clients are required to attend treatment, submit to drug and alcohol testing, abide by a curfew, receive home visits by a probation or surveillance officer, pay fees, attend court sessions, complete community service, and maintain employment.
- Superior Court oversees the Adult Felony Drug Court — a minimum 18 month program.
- State Court oversees the DUI/Drug Court — a minimum 12 month program.

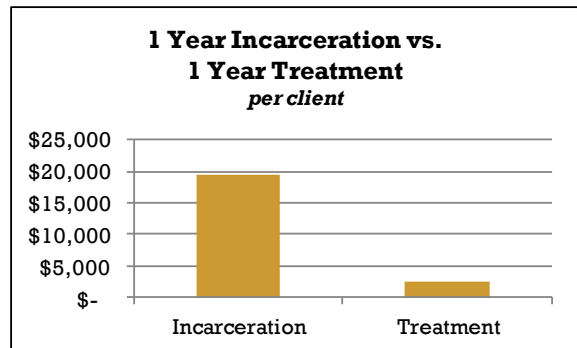
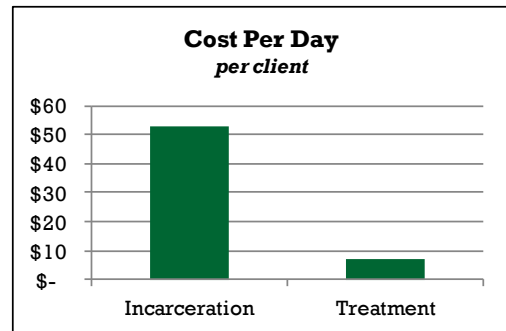
TARGET POPULATION/ELIGIBILITY CRITERIA

ADULT FELONY DRUG COURT	DUI/DRUG COURT
<ul style="list-style-type: none"> • Non-violent offender • Minimum of 2 prior felony convictions • Current felony charge in Clayton County • Must live in Clayton County while in Drug Court and during probation • Must voluntarily agree to enter Drug Court • Must have an identifiable substance abuse problem 	<ul style="list-style-type: none"> • Current DUI charge is either the offender's 2nd DUI in the last 5 years, or • 3rd or more DUI in the offender's life • Must be a Clayton County resident at time of sentencing
