RESOLUTION NO. 2013 - 32

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF AN ABANDONED VEHICLE TO BE ASSIGNED TO THE POLICE DEPARTMENT FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Department Uniform Patrol Division impounded a 2001 Black Haulmark Trailer, VIN # T865746 during a criminal investigation; and

WHEREAS, the Superior Court of Clayton County received and approved an application for order to retain said trailer to be utilized by the County under court order in case number 2009CV05156-8; and

WHEREAS, the Director of Fleet Maintenance has determined said trailer is suitable for service as a county vehicle; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said trailer and assigning it to the Clayton County Police Department to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, to accept title to a 2001 Black Haul Trailer, VIN # T865746; to assign said trailer to the Clayton County Police Department vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court order number 2009CV05156-8. The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution. The Board of Commissioners further authorizes the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




