RESOLUTION 2012 – 25

A RESOLUTION PROVIDING FOR THE RECOMMENDATION OF THE BOARD OF COMMISSIONERS THAT LEGISLATION BE INTRODUCED IN THE 2012 REGULAR SESSION OF THE GEORGIA GENERAL ASSEMBLY PROVIDING FOR THE REDELINEATION OF COMMISSIONER DISTRICTS ACCORDING TO POPULATION USING THE UNITED STATES DECENNIAL CENSUS OF 2010 FOR THE STATE OF GEORGIA; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, as a result of the United States Decennial Census of 2010 for the State of Georgia, the population as well as the demographics of Clayton County have changed to the extent that it is appropriate to re-delineate the Commissioner Districts for the next general election in 2012; and

WHEREAS, the Board of Commissioners is recommending a new map delineating the Commissioner Districts according to criteria promulgated by the U.S. Justice Department be submitted to the Clayton County Delegation for introduction with redistricting legislation in the 2012 regular session of the Georgia General Assembly; and

WHEREAS, it appears to be in the best interest of the citizens of Clayton County to have such local legislation introduced providing for the re-delineation of the Commissioner Districts in Clayton County in accordance with the map submitted herewith.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby recommends that the Clayton County Delegation to the Georgia General Assembly introduce local legislation in the 2012 regular session of the Georgia General Assembly delineating new Commissioner

Districts. Such legislation shall provide for the re-delineation of Commissioner Districts according to the U.S. Department of Commerce, Bureau of Census, report of the United States Decennial Census of 2010 for the State of Georgia, as is more fully set out in the County map attached hereto by reference incorporated herein.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
