RESOLUTION NO. 2012 - 31

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW RAINBOW HOUSE, INC. TO SPONSOR AND HOST A 3-ON-3 TRUE BALLERS BENEFIT BASKETBALL TOURNAMENT AS A FUNDRAISER AT THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, Rainbow House, Inc. (the "Promoter") desires to sponsor and host on March 24, 2012 a 3-on-3 True Ballers Benefit Basketball Tournament (the "Event") as a fundraiser at the Virginia Burton Gray Recreation Center in Clayton County, Georgia; and

WHEREAS, the Parks and Recreation Department recommended the non-profit rate of \$750.00 for use of the Virginia Burton Gray Recreation Center, and Promoter now requests that the Board of Commissioners waive this rental fee entirely; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the Event, with no capital expense to Clayton County, and any funds raised from the Event will benefit the Rainbow House Children's Shelter; and

WHEREAS, the Promoter is qualified to organize, promote and manage the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to present the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to allow Rainbow House, Inc. (the "Promoter") to sponsor and host on March 24, 2012 a 3-on-3 True Ballers Benefit Basketball Tournament (the "Event") as a fundraiser at the Virginia Burton Gray Recreation Center. The Board of Commissioners also waives any rental fee imposed by the County for use of the facility for the Event.


Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.




