RESOLUTION NO. 2011 - 08

A RESOLUTION TO APPOINT THE CLERK OF THE SUPERIOR COURT OF CLAYTON COUNTY, GEORGIA TO SERVE AS THE CLERK OF THE MAGISTRATE COURT OF CLAYTON COUNTY, GEORGIA; TO SET COMPENSATION FOR SUCH SERVICES; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to O.C.G.A. § 15-10-105(b) the Board of Commissioners (county governing authority) is authorized to appoint, with the consent of the Clerk of the Superior Court, the Clerk of the Superior Court of Clayton County, Georgia to serve as the Clerk of the Magistrate Court of Clayton County, Georgia; and

WHEREAS, Linda T. Miller, the duly elected Clerk of the Superior Court of Clayton County, Georgia consented to serve as the Clerk of the Magistrate Court of Clayton County, Georgia pursuant to Resolution No. 95-136 and Resolution No. 96-6 that were previously approved by the Board of Commissioners; and

WHEREAS, Linda T. Miller, has consistently served as the Clerk of the Magistrate Court of Clayton County, Georgia since December 19, 1995 pursuant to these aforementioned resolutions; and

WHEREAS, Linda T. Miller submitted her resignation as the Clerk of the Superior Court of Clayton County, Georgia effective December 31, 2010; and

WHEREAS, on December 31, 2010, Linda T. Miller duly appointed Jacqueline D. Wills to serve as the Clerk of the Superior Court of Clayton County, Georgia for the remainder of her term of office and Jacqueline D. Wills was duly sworn-in as the Clerk of the Superior Court of Clayton County, Georgia on December 31, 2010; and

WHEREAS, it appears that a need has arisen for the appointment of a Clerk of the Magistrate Court of Clayton County, Georgia due to the resignation of Linda T. Miller as the Clerk of the Superior Court of Clayton County, Georgia; and

WHEREAS, Jacqueline D. Wills, the duly appointed Clerk of the Superior Court of Clayton County, Georgia has consented to serve as Clerk of the Magistrate Court of Clayton County, Georgia; and

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby appoints Jacqueline D. Wills, Clerk of the Superior Court of Clayton County, Georgia to serve as the Clerk of the Magistrate Court of Clayton County, Georgia. The appointment shall be from henceforth until the time of the expiration of the current term of the Clerk of Superior Court of Clayton County, Georgia. Said appointment shall be at the pleasure of the Board of Commissioners and there shall be a reappointment of said Clerk from elected term to term without further act of Board of Commissioners, unless otherwise modified by the Board of Commissioners or other appropriate authority.




Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




