RESOLUTION NO. 2011 - 20

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW THE COURTNEY S. CROOMS FOUNDATION, INC. TO SPONSOR AND HOST THE FOURTH ANNUAL COURTNEY S. CROOMS MEMORIAL GIRLS BASKETBALL TOURNAMENT AT THE CARL RHODENIZER RECREATION CENTER AND THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES:

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Courtney S. Crooms Foundation, Inc. (the "Promoter") desires to sponsor and host on May 20, 21 and 22, 2011 the Fourth Annual Courtney S. Crooms Memorial Girls Basketball Tournament (the "Event") at the Carl Rhodenizer Recreation Center and the Virginia Burton Gray Recreation Center, both in Clayton County, Georgia; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the Event, with no capital expense to Clayton County, and where funds raised from the Event will provide scholarship opportunities and school supplies for Clayton County youths; and

WHEREAS, the Promoter is qualified to organize, promote and manage the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to present the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to allow the Courtney S. Crooms Foundation, Inc. (the "Promoter") to sponsor and host on May 20, 21 and 22,

2011 the Fourth Annual Courtney S. Crooms Memorial Girls Basketball Tournament (the "Event") at the Carl Rhodenizer Recreation Center and the Virginia Burton Gray Recreation Center.


Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.




