RESOLUTION NO. 2016 - 72

A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ACCEPT A TEMPORARY CONSTRUCTION EASEMENT FROM LAKE SPIVEY GOLF CLUB, INC. FOR THE CONSTRUCTION OF A PUBLIC PATHWAY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL DOCUMENTS NECESSARY, AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PRUPOSES.

WHEREAS, Clayton County is in need of a temporary construction easement for the construction of a pathway for use by the public for walking, hiking, running, other pedestrian uses, biking and golf carts, near the intersection of the northern right-of-way of Walt Stephens Road and the eastern right-of-way of Members Drive, in Clayton County, Georgia; and

WHEREAS, the Lake Spivey Golf Club, Inc. is willing to grant Clayton County a temporary construction easement for the construction of a pathway for use by the public for walking, hiking, running, other pedestrian uses, biking and golf carts, near the intersection of the northern right-of-way of Walt Stephens Road and the eastern right-of-way of Members Drive, in Clayton County, Georgia; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting the temporary construction easement from the Lake Spivey Golf Club, Inc. for the purposes set forth herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept a temporary construction easement for the construction of a pathway for use by the public for walking, hiking, running, other pedestrian uses, biking and golf carts, near the intersection of the northern right-of-way of Walt Stephens Road and the eastern right-of-way of Members Drive, in Clayton County, Georgia. A copy of the temporary easement is attached.

Section 2. The Board of Commissioners authorizes the Chairman to execute any necessary documents and otherwise to perform all other acts necessary to accomplish the intent of this resolution.

Section 3. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, as may be required.

Section 4. This resolution shall become effective upon its approval by the Board of Commissioners.




