RESOLUTION NO. 2016 -137

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO CONVEY A PERMANENT EASEMENT AND A TEMPORARY CONSTRUCTION EASEMENT TO THE CLAYTON COUNTY WATER AUTHORITY ASSOCIATED WITH CONSTRUCTION OF A NEW SANITARY SEWER FORCE MAIN; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL DOCUMENTS NECESSARY, AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Water Authority is in need of a permanent easement and a temporary construction easement to replace and maintain the sanitary sewer force main on the property identified by tax map parcel number 12048A I007 located at 102 Cecilia Circle, in Jonesboro, Clayton County, Georgia; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by conveying a permanent easement and a temporary construction easement to the Clayton County Water Authority for the purposes set forth herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to convey to the Clayton County Water Authority a permanent easement and a temporary construction

easement for the property identified by tax map parcel number 12048A I007 located at 102 Cecilia Circle, in Jonesboro, Clayton County, Georgia. A description of the easements to be conveyed are more fully set forth in Exhibit "A" attached hereto.

Section 2. The Board of Commissioners authorizes the Chairman to execute any necessary documents and otherwise to perform all other acts necessary to accomplish the intent of this resolution.

Section 3. This resolution shall become effective upon its approval by the Board of Commissioners.
