RESOLUTION NO. 2016 - 163

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST FOR THE ROTARY CLUB OF CLAYTON COUNTY, INC. TO HOST A SERIES OF EVENTS FOR INTERNATIONAL COLLEGE STUDENTS AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department (the "Department") received a Special Facility Use Request from the Rotary Club of Clayton County, Inc. (the "Request") for use of the VIP Complex, St. Martin Pavilion and Nassau Building at Clayton County International Park (the "Park") for the purpose of hosting a meet and greet, team building and other group activities, lunch and a departure farewell for 70 to 75 international college students; and

WHEREAS, the Park space will be utilized between the hours of 12:00 p.m. on September 9, 2016 and 7:00 p.m. on September 11, 2015; and

WHEREAS, the Department requests that Rotary Club of Clayton County, Inc. will pay the County for the following services at the following rates:

- \$350.00 – Special Event Fee (this is half price because this is a 501(c)3 non-profit)
- \$160.00 – (1) Event Coordinator (Saturday 10:00 a.m. – 4:00 p.m. @ \$20 per hour)
- \$160.00 – (4) Lifeguards (Saturday 12:00 p.m. – 4:00 p.m. @ 10 per hour)
- \$40.00 – (1) Event Maintenance Staff (Saturday 12:00 p.m. – 4:00 p.m. @ 10 per hour)
- For a total reduced rate of \$710.00; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the request for use of the space, at the stated rate, and for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners hereby grants the Rotary Club of Clayton County, Inc.'s Special Facility Use Request to host a meet and greet, team building and other group activities, lunch and a departure farewell for 70 to 75 international college students at the VIP Complex, St. Martin Pavilion and Nassau Building at Clayton County International Park between the hours of 12:00 p.m. on September 9, 2016 and 7:00 p.m. on September 11, 2016.

Section 2. The Clayton County Board of Commissioners hereby authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. Rotary Club of Clayton County, Inc. will pay to the County for the use of the facilities and services as follows:

- \$350.00 – Special Event Fee (this is half price because this is a 501(c)3 non-profit)
- \$160.00 – (1) Event Coordinator (Saturday 10:00 a.m. – 4:00 p.m. @ \$20 per hour)
- \$160.00 – (4) Lifeguards (Saturday 12:00 p.m. – 4:00 p.m. @ 10 per hour)
- \$40.00 – (1) Event Maintenance Staff (Saturday 12:00 p.m. – 4:00 p.m. @ 10 per hour)
- For a total reduced rate of \$710.00.


Section 4. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance


