ORDINANCE NO. 2016-178

AN ORDINANCE TO AMEND THE *CODE OF CLAYTON COUNTY, GEORGIA*, AS AMENDED, SPECIFICALLY PART I - RELATED LAWS PERTAINING TO CLAYTON COUNTY, CHAPTER 6 - ALCOHOLIC BEVERAGES, ARTICLE I. - IN GENERAL, SECTION 6-6. – LICENSE RESTRICTIONS, ARTICLE III. - LICENSING GENERALLY, SECTION 6-67. – FEES, AND ARTICLE IV. - WHOLESALE LICENSE, SECTION 6-93. – FEE, SO AS TO AMEND ALCOHOL LICENSE REQUIREMENTS AND FEES; TO REPEAL CONFLICTING LAWS, ORDINANCES, AND RESOLUTIONS; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE OF THIS ORDINANCE; AND FOR OTHER PURPOSES.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY ORDAINED

**Section 1.** The *CODE OF CLAYTON COUNTY, GEORGIA*, as amended, is hereby further amended by amending Part I - Related Laws Pertaining to Clayton County, Chapter 6 - Alcoholic Beverages, Article I. - In General, Section 6-6. – License restrictions, by deleting subsection (c) and subsection (d), so that Section 6-6. will now read as follows:

“Sec. 6-6. - License restrictions.

(a) No person shall hold a license to operate as a retail consumption dealer or retail dealer who also has an interest in a license to operate as a wholesale dealer.

(b) No elected or appointed official, employee or agent of the county, directly or indirectly, shall be a licensee.”

**Section 2.** The *CODE OF CLAYTON COUNTY, GEORGIA*, as amended, is hereby further amended by amending Part I - Related Laws Pertaining to Clayton County, Chapter 6 - Alcoholic Beverages, Article III. - Licensing Generally, Section 6-67. – Fees, by deleting subsection (a) and replacing it with a new subsection (a) to read as follows:

“(a) The fee schedule for all alcoholic beverage licenses shall be as follows:

(1) Restaurant, retail consumption, \$4,000.00.

(2) Restaurant, malt beverage and wine retail consumption, \$4,000.00.

(3) Private clubs, retail consumption, or sports clubs, retail consumption, \$1,000.00.

(4) Retail dealer, \$4,000.00.”

**Section 3.** The *CODE OF CLAYTON COUNTY, GEORGIA*, as amended, is hereby further amended by amending Part I - Related Laws Pertaining to Clayton County, Chapter 6 - Alcoholic Beverages, Article IV. – Wholesale License, Section 6-93. – Fee, by deleting subsection (a) and replacing it with a new subsection (a) to read as follows:

“(a) The license fee for each wholesale dealer shall be \$1000.00.”

**Section 4.** All laws, ordinances and resolutions, or parts thereof, which conflict with the provisions of this Ordinance are hereby repealed.

**Section 5.** If any part of this Ordinance shall be declared unconstitutional by the valid judgment of any court of competent jurisdiction, such unconstitutionality shall not affect the remainder of this enactment, and such remainder shall remain in full force and effect.

**Section 6.** This Ordinance shall become effective upon its approval by the Board of Commissioners.


