A RESOLUTION TO DEDICATE THE RECREATION ROOM AT THE FRANK BAILEY SENIOR CENTER TO MS. MAGGIE KATIE BROWN KIDD; TO AUTHORIZE THE PURCHASE AND ERECTION OF A PLAQUE ON THE DESIGNATED ROOM TO REFLECT THE DEDICATION; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Ms. Kidd will be 112 years old on December 8, 2016; and

WHEREAS, Ms. Kidd is currently the oldest living Clayton County resident, the oldest living Georgian (as designated by Baylor College of Medicine Center on Aging), and the oldest living African American in the United States (as designated by the African American Centenarian Project, D. Barr & P. Cole); and

WHEREAS, Ms. Kidd is a Super Centenarian that enjoys Sunday Church services, arts and crafts, especially quilting; and

WHEREAS, Clayton County is proud to have Ms. Kidd as a resident and wants to honor her life; and

WHEREAS, the Clayton County Board of Commissioners wishes to dedicate the Recreation Room at the Frank Bailey Senior Center to Ms. Maggie Katie Brown Kidd.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED




