RESOLUTION NO. 2015-67

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT A BOAT AND TRAILER FROM A CLAYTON COUNTY POLICE DEPARTMENT DRUG INVESTIGATION; TO AUTHORIZE THE POLICE DEPARTMENT TO RETAIN THESE ITEMS FOR OFFICIAL USE BY THE POLICE DIVE TEAM; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police-Drug Task Force Division seized a 1997 Playbuoy Eagle Angler Pontoon Boat, Registration #GA6314EM, BHN #DVN25454J697; 1997 Playbuoy Boat Eagle Angler Trailer, VIN 2022EGLANEG0028 during a drug investigation; and

WHEREAS, the Clayton County Police-Drug Task Force did petition the District Attorney for forfeiture of said boat and boat trailer to the County; and

WHEREAS, the Superior Court of Clayton County has forfeited ownership and titles of said items to the County under a court order in case number 2014-CV-03074-6; and

WHEREAS, it was determined that the boat and boat trailer can be effectively used by the Police Department's Dive Team for the benefit of the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by retaining of the said boat and boat trailer for official use by the Police Department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS


OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, to retain for official use by the Police Department's Dive Team, a 1997 Playbuoy Eagle Angler Pontoon Boat, Registration # GA6314EM, BHN # DVN25454J697 and a 1997 Playbuoy Boat Eagle Angler Trailer, VIN 2022EGLANEG0028. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
