RESOLUTION NO. 2015-174

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AGREEMENT WITH THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH CLAYTON STATE UNIVERSITY WILL FACILITATE A SERVICE LEARNING PROJECT FOR CLAYTON STATE STUDENTS AT CLAYTON COUNTY SENIOR CENTERS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County's Senior Services Department wishes to enter into an Agreement with the Board of Regents of the University System of Georgia; and

WHEREAS, the Agreement will allow Clayton State University (the "University") to facilitate a service learning project for Introduction to Psychology students at the County Senior Services Centers; and

WHEREAS, the University wishes to utilize the Frank Bailey and Charley Griswell Senior Centers; and

WHEREAS, the County deems it in its best interest of Clayton County, and the County will best be served by entering into an Agreement with Board of Regents of the University System of Georgia, for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners authorizes Clayton County to enter into an Agreement with the Board of Regents of the University System of Georgia, providing

for the terms and conditions under which Clayton State University will facilitate a service learning project for Introduction to Psychology students at the Clayton County Senior Services Centers. The Board of Commissioners authorizes the Chairman to execute the Agreement and otherwise perform all acts necessary to accomplish the intent of this Resolution. The Agreement shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman may approve.

Section 2. The effective date of this Resolution shall be when approved by the Board of Commissioners of Clayton County.


