RESOLUTION NO. 2014-65

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT TO ALLOW LENEILLE MOON TO SPONSOR AND HOST A 5K WALK AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Leneille Moon (the "Promoter") desires to sponsor and host a 5K Walk at Clayton County International Park on May 3, 2014 from 7:00 a.m. to 12:00 p.m.; and

WHEREAS, the event is a fundraiser to raise money for a book series, and the Promoter will assign 95 percent of the proceeds to the book publication company and donate the remaining 5 percent to the Keys for Kids Organization; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended Special Event Fee of \$700.00, a Coordinator fee of \$50.00 for safety and security purposes (\$10.00 per hour for five hours) and a Maintenance Fee of \$50.00 (\$10 per hour for five hours) for the event; and

WHEREAS, subject to the foregoing, the Promoter shall have sole responsibility for organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a license agreement to allow the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement to allow Leneille Moon to sponsor and host a 5K Walk at Clayton County International Park facility on May 3, 2014 from 7:00 a.m. to 12:00 p.m. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment "A" and otherwise perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the Special Event Fee of \$700.00, a Coordinator fee of \$50.00 and a Maintenance Fee of \$50.00 to be paid by the Promoter for the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
