RESOLUTION NO. 2014-67

A RESOLUTION TO RECOGNIZE THE YEARS OF SERVICE OF POLICE CANINE YASMINE, TO GRANT A CONDITIONAL GIFT FOR HER REMAINING YEARS, AND TO PROVIDE FOR HER RETIREMENT FROM ACTIVE SERVICE.

WHEREAS, the County desires to recognize the eight years of faithful service of police canine Yasmine; and

WHEREAS, the County commends and acknowledges her assistance in the explosive detection field and instrumental in searching of 135 buildings in her career, and

WHEREAS, Yasmine was first employed in June 2006, she is now nine years of age, has developed acute arthritis in her back elbows, a rear tendon was replaced several years ago, where now she has reached the end of her ability to work as an explosive detection dog; and

WHEREAS Lieutenant George Whitehorn has been Yasmine's human partner since 2006 and wishes to provide for Yasmine in her retirement and for her remaining years.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED:

Section 1. The County formally recognizes and commends Lieutenant George Whitehorn and his canine partner, Yasmine, for years of outstanding service to the community.


Section 2. The Chairman is authorized to enter into a contract to provide for a conditional gift of canine Yasmine to George Whitehorn. Where George Whitehorn is to have and to hold Yasmine for the remainder of Yasmine's life, on the condition that Yasmine shall not be sold, loaned, given to another, or used as a police explosive detection canine; and on the further condition that should George Whitehorn be no longer able or willing to provide for Yasmine or should there be a default of the stated condition, that Yasmine shall be returned to the County's Animal Control Unit.

Section 3. Police canine Yasmine is hereby retired from active service with the Clayton County Police Department.

SO RESOLVED, this the 18<sup>th</sup> day of March, 2014.


