RESOLUTION NO. 2014-209

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT TWO SEIZED VEHICLES PURSUANT TO CLAYTON COUNTY SUPERIOR COURT JUDGMENTS AND ORDERS OF FORFEITURE AND DISPOSITION OF PROPERTY; TO AUTHORIZE ASSIGNMENT OF SUCH VEHICLES TO THE SHERIFF'S OFFICE FLEET; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Office seized a 2001 Honda Odyssey, VIN# 2HKRL18671H6061 and a 2002 BMW 745i, VIN# WBAGL63432DP50492, during VICE investigations; and

WHEREAS, the Sheriff's Office did petition the District Attorney for forfeiture of said vehicles to the County; and

WHEREAS, the Superior Court of Clayton has forfeited ownerships and titles of said vehicles to the County under court orders in Case Numbers 2013-CV-05275-5 and 2014-CV-01508-6; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicles are suitable for service as County vehicles and will be used in Sheriff Department operations; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said vehicles and assigning them

to the Clayton County Sheriff's Office to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept titles to a 2001 Honda Odyssey, VIN# 2HKRL18671H6061 and 2002 BMW 745i, VIN# WBAGL63432DP50492, and to assign said vehicles to the Sheriff's Office vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court orders case numbers 2013-CV-05275-5 and 2014-CV-01508-6. The Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
