RESOLUTION NO. 2014-265

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT TO ALLOW CLAYTON COLLABORATIVE AUTHORITY TO SPONSOR AND HOST A 5K WALK/RUN FOR DOMESTIC VIOLENCE AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton Collaborative Authority (the "Promoter"), in conjunction with GrassRoots Leadership Institute, desire to sponsor and host their 5K Run/Walk for Domestic Violence on November 1, 2014 from 6:30 a.m. to 11:00 a.m. at the Clayton County International Park, and invite promotional vendors; and

WHEREAS, the Promoter will use this event to raise funds to increase awareness of domestic violence; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a License Agreement with the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement to allow Clayton Collaborative Authority, in conjunction with GrassRoots Leadership Institute, to sponsor and host their 5K Run/Walk for Domestic Violence on November 1, 2014 at the Clayton County International Park. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto, subject to any

minor changes or deletions that the Board of Commissioner may approve, and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
