RESOLUTION NO. 2014-334

A RESOLUTION PROVIDING FOR THE REPEAL OF RESOLUTION NO. 2014-321 AND CORRECTION OF A SCRIVENER'S ERROR IN RESOLUTION NO. 2014-304; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners approved Resolution No. 2014-321 authorizing the County to exercise its powers of eminent domain for the purpose of acquiring certain parcels of land; and

WHEREAS, Resolution No. 2014-304, which contained a scrivener's error, should have included 5161 Hanover Street, Tax Parcel No. 16; and

WHEREAS, this scrivener's error was corrected in Resolution No. 2014-321 which struck portions of Resolution No. 2013-176 in error; and

WHEREAS, the Board of Commissioners deems it in the County's best interest and the objectives provided herein can be best served by repealing Resolution No. 2014-321 and correcting a Scrivener's error in Resolution No. 2014-304.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby repeals Resolution No. 2014-321. The language in the first WHEREAS section of Resolution No. 2014-304 is hereby stricken in its entirety and the following is substituted in lieu thereof:

(1) The Board of Commissioners desires to exercise its powers of eminent domain in accordance with provisions of Georgia Laws for the purpose of acquiring certain portion of properties for use by the Clayton County Department of Transportation and

Development for the Godby Road Widening Improvement Project, specifically that certain tracts and parcels of land known as:

5161 Hanover Street, Tax Parcel No. 16;

2060 Southampton Road, Tax Parcel No. 39; and


Section 2. Except as otherwise modified herein, Resolution No. 2014-304 remains in full force and effect according to its terms.


