RESOLUTION NO. 2013 - 74

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH VARIETY ENTERTAINMENT, INC. PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH "THE ATLANTA HARLEY'S ONLY BIKE SHOW AND DAY PARTY" WILL BE HOSTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Variety Entertainment, Inc. (the "Promoter") wishes to utilize the Upper Field and other specified areas at Clayton County International Park (the "Location") to host "The Atlanta Harley's Only Bike Show and Day Party," consisting of food, a bike competition, and amplified music, and where the County is solely responsible for providing personnel for facility maintenance and program coordination; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on May 19, 2013 from approximately 8:00 A.M. until 11:00 P.M., with the purposes of assisting in the development of a branding image for the International Park as a multipurpose venue and providing citizens a place to be entertained in a family-friendly atmosphere; and

WHEREAS, the Promoter is qualified to organize and facilitate projects that contribute positively to the community's morale and promote community involvement by offering positive, family-friendly social and musical entertainment; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with Variety Entertainment, Inc. (the “Promoter”) providing for hosting an event entitled, “The Atlanta Harley’s Only Bike Show and Day Party” to be held on May 19, 2013 at the Clayton County International Park. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto and otherwise perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.

SO RESOLVED, this the 12<sup>th</sup> day of March, 2013.


