RESOLUTION NO. 2013 -108

A RESOLUTION TO APPROVE A SPECIAL FACILITY USE REQUEST TO ALLOW CLAYTON COUNTY UGA COOPERATIVE EXTENSION DEPARTMENT TO HOST A 4-H AWARDS CEREMONY TO HONOR FIFTH THROUGH TWELFTH GRADE STUDENTS AT THE J.CHARLEY GRISWELL SENIOR CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER OR FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, The Clayton County UGA Cooperative Extensive Department (the "Hosts") wish to utilize the J. Charley Griswell Senior Center (the "Location") to host a 4-H Awards Ceremony to honor fifth through twelfth grade students who are 4-H members; and

WHEREAS, the Hosts wish to utilize the Location on April 25, 2013 from approximately 2:15 P.M. until 9:15 P.M.; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Hosts to facilitate this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners agrees to allow the Clayton County UGA Cooperative Extensive Department to host a 4-H Awards Ceremony at the J. Charley Griswell Senior Center on April 25, 2013 to honor fifth through twelfth grade students who

are 4-H members. The Board of Commissioners authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners authorizes the Chief Financial Officer and the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

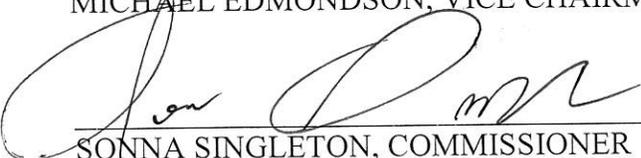
Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.

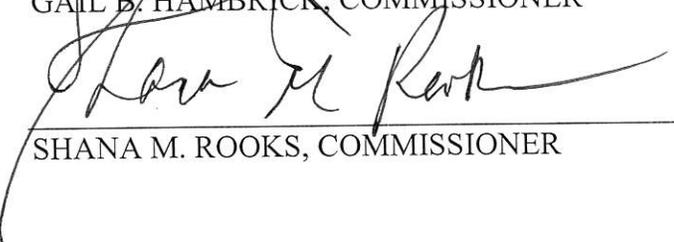

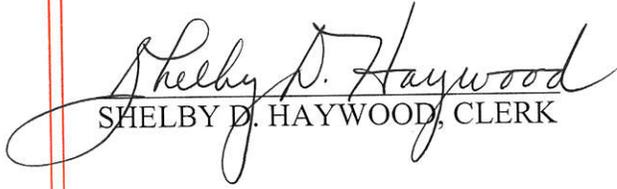
