RESOLUTION NO. 2013 -92

A RESOLUTION TO ENTER INTO A LICENSE AGREEMENT WITH CARIBBEAN ASSOCIATION OF GEORGIA, INC. TO HOST THE "SOUTH METRO CARIBBEAN FESTIVAL" AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER OR THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE AND WHEN NECESSARY TO REFLECT APPROPRIATE REVENUE SOURCES AND EXPENSES, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Caribbean Association of Georgia, Inc. (the "Association") wishes to utilize Upper Field of the Clayton County International Park (the "Location") to host a cultural festival entitled, "South Metro Caribbean Festival," which will include vendors, live entertainment, dancing, inflatables, games, contests, displays and prize give-aways; and

WHEREAS, the Association, which is partnering with various Clayton County agencies, wishes to utilize the Location in Jonesboro, Georgia on August 24, 2013 from approximately 8:00 A.M. until 8:00 P.M., with the purpose of providing citizens a place to be entertained in a family-friendly atmosphere; and

WHEREAS, the Association requested that all fees for use of the Location be waived, however, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's field fee of \$350.00 to be charged in connection with the event; and

WHEREAS, the Association is qualified to organize and facilitate projects that enhance cultural awareness, invigorate the local economy, contribute positively to the community's morale and promote community involvement by offering positive, family-friendly cultural and musical entertainment; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Association to host this event for the total fee recommended above by the Department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners agrees to allow the Caribbean Association of Georgia, Inc. (the "Association") to host the "South Metro Caribbean Festival" to be held on August 24, 2013 at Upper Field of the Clayton County International Park. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment "A" and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the rate of \$350.00 to be charged to the Association in connection with the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
