RESOLUTION NO. 2013 - 143

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A PARTNERSHIP AGREEMENT WITH THE GEORGIA CENTER FOR YOUTH AND FAMILIES, INC. TO HOST THE 2013 DOUBLE DUTCH "JUMP OFF" PROGRAM IN CONJUNCTION WITH THE CLAYTON COUNTY PARKS AND RECREATION SUMMER CAMP PROGRAM; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in an effort to introduce children to non-traditional sports, enhance gross motor skills, hand/eye coordination and team-building skills, the Clayton County Parks and Recreation Department and The Georgia Center for Youth and Families, Inc. (the "Provider") wish to conduct the 2013 Double Dutch "Jump Off" Program (the "Event") at the Carl Rhodenizer, Jim Huie, South Clayton, and Virginia Burton Gray Recreation Centers; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Director of the County's Parks and Recreation Department desires to partner with the Provider to host the Event on June 10, 2013 through August 9, 2013, with the final competition taking place on August 17, 2013; and

WHEREAS, the Clayton County Parks and Recreation Department shares responsibility for organizing, promoting and managing the Event, with no additional cost to Clayton County; and

WHEREAS, there will be no impact on other programs and/or services being provided at County facilities; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a Partnership Agreement with the Provider to host the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a Partnership Agreement with The Georgia Center for Youth and Families, Inc. to host the 2013 Double Dutch "Jump Off" Program on June 10, 2013 through August 9, 2013 at the Carl Rhodenizer, Jim Huie, South Clayton, and Virginia Burton Gray Recreation Centers, with the final competition taking place on August 17, 2013, to introduce children to non-traditional sports, enhance gross motor skills, hand/eye coordination and team-building skills.



Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
