RESOLUTION NO. 2013- 222

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY BOARD OF COMMISSIONERS ON BEHALF OF THE CLAYTON COUNTY JUVENILE COURT, TO ACCEPT JUVENILE JUSTICE INCENTIVE GRANT FUNDING TO ENHANCE CURRENT COURT SERVICES FOR HIGH-RISK YOUTH AND TO ENTER INTO A SUBRECIPIENT AGREEMENT WITH SOUTHWEST KEY, FAMILY AND TRANSPORTATION SERVICES, LLC TO PROVIDE THE SERVICES OUTLINED IN THE GRANT AGREEMENT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE GRANT AGREEMENT AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County applied for \$500,000.00 of Juvenile Justice Incentive Grant Program monies as administered by the Criminal Justice Coordinating Council and was awarded \$200,000.00; and

WHEREAS, this funding will allow the County to implement Family Functional Therapy Services to 49 high - risk juvenile offenders and their families beginning October 1, 2013 and ending June 30, 2013; and

WHEREAS, Southwest Key, Family & Transportation Services, LLC is a private company and sub-recipient organization selected to perform the services outlined in the grant agreement; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by authorizing Juvenile Court to accept Juvenile Justice Incentive Grant funding and to enter into a Subrecipient Agreement with Southwest Key, Family & Transportation Services, LLC for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County Juvenile Court to accept Juvenile Justice Incentive Grant funding in the amount of \$200,000.00. The Board of Commissioners hereby authorizes the Chairman to execute the Subrecipient Agreement for use of the Juvenile Justice Incentive Grant Program Funds between Clayton County and Southwest Key, Family & Transportation Services, LLC, and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


