RESOLUTION NO. 2013 - 223

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST TO ALLOW STATE SENATOR GAIL DAVENPORT TO HOST A FAMILY DAY CELEBRATION FOR CLAYTON COUNTY CITIZENS AT THE SOUTH CLAYTON RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from State Senator Gail Davenport (the "Host") for use of the South Clayton Recreation Center (the "Location") to host a Family Day Celebration for the purpose of appreciating, entertaining and recognizing veterans and non-veterans of Clayton County on September 21, 2013; and

WHEREAS, the Host wishes to utilize the Location for the event from 11:00 a.m. until 4:00 p.m.; and

WHEREAS, Clayton County deems it in the best interest of the County and the County will best be served by allowing the Host to facilitate this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to grant Senator Gail Davenport a Special Facility Use Request to host a Family Day Celebration for veterans and non-veterans of Clayton County at the South Clayton Recreation Center on September

21, 2013, from 11:00 a.m. until 4:00 p.m. The Board authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective upon its approval by the Board of Commissioners.


