RESOLUTION NO. 2012 - 64

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW REAL HELP NETWORK, INC. TO HOLD A KITE FLYING CONTEST AT THE GERALD MATTHEWS COMPLEX; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS NECESSARY, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Real Help Network, Inc. (the "Promoter") desires to sponsor and host on April 21, 2012, a kite flying contest at the Gerald Matthews Complex on the soccer field; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the event will raise funds for the Promoter's substance abuse and recovery education program; and

WHEREAS, the Promoter will pay Clayton County \$100.00, which is the discount rate for non-profit organizations, for use of the field; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to present this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to allow Real Help Network, Inc. to sponsor and host a kite flying contest at the Gerald Matthews Complex on April 21, 2012.


Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.




