RESOLUTION NO. 2012 – 107

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO CONTRACTS WITH THE STATE OF GEORGIA, DEPARTMENT OF FAMILY AND CHILDREN SERVICES ON BEHALF OF THE CLAYTON COUNTY EXTENSION SERVICE, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH PARENT AIDE SERVICES, EARLY INTERVENTION SERVICES, AND SAFECARE SERVICES, RESPECTIVELY, WILL BE DELIVERED AND ADMINISTERED, AND TO ACCEPT GRANT FUNDS FROM THE STATE OF GEORGIA TO FUND THE PARENT AIDE SERVICES PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE CONTRACT ON BEHALF OF THE COUNTY, AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE AND WHEN NECESSARY TO REFLECT APPROPRIATE REVENUE SOURCES AND EXPENSES, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (the “County”) desires to make Parent Aide, Early Intervention, and SafeCare Services, each of which encompasses the Parent Aide Services Program (the “Program”), available to its citizens; and

WHEREAS, the State of Georgia, Department of Family and Children Services (“DFACS”), which is a part of the Division of Family Services of the Department of Human Services, will provide funding and oversight of the Program; and

WHEREAS, reimbursement to the County from DFACS will be calculated on fee per service based on the fee schedules for Parent Aide, Early Intervention, and SafeCare Services, separately, with no match required from the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by entering into the Contracts for Parent Aide Services for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into the Contracts for Parent Aide Services on behalf of Clayton County Extension Service with the State of Georgia, Department of Family and Children Services to accept grant funds associated with the Parent Aide Services Program. The agreement shall be in the forms attached hereto.

Section 2. The Board of Commissioners hereby authorizes the Chairman to execute the contracts on behalf of the County and to perform all other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


