RESOLUTION NO. 2012 -109

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH ITS PARKS AND RECREATION DEPARTMENT, TO ENTER INTO THREE SPONSOR/SITE AGREEMENTS WITH BRIGHT FROM THE START PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE UNITED STATES DEPARTMENT OF AGRICULTURE'S SUMMER FOOD SERVICE PROGRAM WILL BE ADMINISTERED; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENTS AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, from 2007 through 2011, the Clayton County Parks and Recreation Department has participated in the United States Department of Agriculture's (USDA) Summer Food Service Program (the "Program") under the sponsorship of the City of Atlanta. This year, the sponsorship by the City of Atlanta is not available; and

WHEREAS, sponsorship for the Program, which is administered by Bright From The Start (the "Provider"), is currently available through the Christian Life Center of Atlanta (the "Sponsor"); and

WHEREAS, the Program will be in operation from June 11, 2012 through July 27, 2012 to serve free lunch to all Summer Camp participants at the Jim Huie, Carl Rhodenizer and Virginia Burton Gray Recreation Centers; and

WHEREAS, site supervisors will be trained on the rules and facilitation of the meals by the Sponsor; and

WHEREAS, there is no budgetary impact on the County in connection with the Program; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into three Sponsor/Site Agreements with the Provider for the above-stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into three Sponsor/Site Agreements with Bright From The Start, providing for the terms and conditions under which the Parks and Recreation Department will participate in the United States Department of Agriculture's (USDA) Summer Food Service Program under the sponsorship of the Christian Life Center of Atlanta. The Board of Commissioners hereby authorizes the Chairman to execute the Agreements and to perform all other acts necessary to accomplish the intent of this Resolution. The Agreements shall be in the forms attached hereto, subject to such minor changes, insertions or deletions as the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




