RESOLUTION NO. 2012 - 119

A RESOLUTION AUTHORIZING THE COUNTY TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH DR. JOSEPH A. HILL, PH.D. FOR PRE-EMPLOYMENT PSYCHOLOGICAL EVALUATION SERVICES ON BEHALF OF THE CLAYTON COUNTY POLICE DEPARTMENT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION. TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County is in need of the professional services of a doctor to perform pre-employment psychological evaluations; and

WHEREAS, the County desires to enter into a Professional Services Agreement with Dr. Joseph A. Hill, Ph.D. (Dr. Hill) to provide for such services; and

WHEREAS, Dr. Hill has agreed to provide such services at a fee of \$250.00 per evaluation; and

WHEREAS, the County deems it in its best interest of Clayton County, and the County will best be served by entering into an Agreement with Dr. Joseph A. Hill, Ph.D. for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Professional Services Agreement with Dr. Joseph A. Hill, Ph.D. providing for the terms and conditions under which pre-employment evaluation services will be rendered to the County. Further, the Board of Commissioners authorizes the Chairman to execute the Agreement (attached hereto as Exhibit "A") The Chairman is further authorized to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement.

Section 2. The effective date of this Resolution shall be when approved by the Board of Commissioners of Clayton County.






