RESOLUTION 2012 – 153

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH THE CLAYTON COLLABORATIVE AUTHORITY PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH CLAYTON COUNTY WILL HOST THE ATLANTA CONTEMPORARY JAZZ & NEO-SOUL FESTIVAL, SPONSORED BY COMMISSIONER SONNA SINGLETON, THE BOARD OF COMMISSIONERS AND THE CLAYTON COUNTY COUNCIL OF PTAs; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY NECESSARY DOCUMENTS AND TO OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton Collaborative Authority (the “Company”) wishes to utilize the Clayton County International Park (the “Location”) to offer innovative and first-class entertainment to the citizens of Clayton County at a reasonable admission as well as to help promote the International Park Amphitheater as a destination point for future events; and

WHEREAS, the Atlanta Contemporary Jazz & Neo-Soul Festival (the “Festival”) will take place on Friday, August 17, 2012, from 5:30 P.M. until 10:00 P.M. and on Saturday, August 18, 2012, from 11:30 A.M. until 10:00 P.M.; and

WHEREAS, the Festival will also include an Opening Reception on Thursday, August 16, 2012, from 6:00 P.M. until 9:00 P.M.; and

WHEREAS, the Company will be responsible for the payment of all expenses and costs associated with the Festival with the County retaining the first \$10 of all ticket sales and any remaining proceeds going to the Clayton County Council of PTAs to support the performing arts in Clayton County Schools; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a License Agreement for the reasons stated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes the County to enter into a License Agreement with the Clayton Collaborative Authority providing for terms and conditions under which the County will host the Atlanta Contemporary Jazz & Neo-Soul Festival, sponsored by Commissioner Sonna Singleton, the Board of Commissioners and the Clayton County Council of PTAs to be held on August 16<sup>th</sup>, 17<sup>th</sup> and 18<sup>th</sup>, 2012, at the Clayton County International Park. The Board authorizes the Chairman to execute any necessary documents and to otherwise perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective upon its approval by the Board of Commissioners.
