RESOLUTION 2012 – 167

A RESOLUTION AUTHORIZING THE NETBALL ASSOCIATION OF SOUTH METRO ATLANTA TO FACILITATE A YOUTH NETBALL PILOT PROGRAM AT THE GERALD MATTHEWS COMPLEX; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in the Clayton County area for the benefits of the County's citizens; and

WHEREAS, the Netball Association of South Metro Atlanta (the "Promoter"), in partnership with the Women's Sports Foundation, wishes to facilitate a youth netball and physical activity pilot program for Clayton County girls at the Gerald Matthews Complex in Lovejoy; and

WHEREAS, the program will run for six weeks beginning Tuesday, September 4, 2012, with games taking place on Tuesday and Friday evenings from 6:30 P.M. until 8:30 P.M.; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the program, with no capital expenses to the County, and will be responsible for providing all playing equipment, uniform bibs, instructors and game officials; and

WHEREAS, the Promoter is qualified to organize, promote and manage the program; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to facilitate the program.






Section 2. This Resolution shall be effective upon its approval by the Board of Commissioners.
