RESOLUTION NO. 2011 - 120

A RESOLUTION TO PROVIDE FOR A CHANGE IN THE NAME OF THE PUBLIC ROAD RIGHT-OF-WAY OF FULFORD DRIVE TO AIRLINE MUSEUM WAY; TO PROVIDE FOR THE ASSIGNMENT OF THE STREET NUMBER ADDRESS OF 727 FOR THE NATIONAL MUSEUM OF COMMERCIAL AVIATION SITE; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY REQUIRED DOCUMENT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County wishes to change the name of Fulford Drive in Mountain View, to Airline Museum Way and to assign the street number address 727 to the National Museum of Commercial Aviation site, for a final assigned address of 727 Airline Museum Way, Atlanta, GA 30354; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by renaming the public road right-of-way to Airline Museum Way and to assign the street number address of 727 to the National Museum of Commercial Aviation site.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to rename the public road right-of-way of Fulford Drive to Airline Museum Way and to assign the

street number address of 727 to the National Museum of Commercial Aviation site for a final assigned address of 727 Airline Museum Way, Atlanta, GA 30354. The Board of Commissioners hereby authorizes the Chairman to execute any required document and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.






